Attention all account owners with Direct Deposit from any Federal Government entity (Social Security, IRS, Civil Service, etc.). The federal government requires all federal Social Security, IRS, Civil Service, etc. J. The federal government requires all federal direct deposit payments to be deposited into an account owned by the rightful payee. If a government payment is made payable to an individual it can be deposited into an individual account OR into a joint account as long as the payee is named as a joint owner. If a government payment is titled in any other way [payable to more than one individual or to an individual as Rep Payee], the account must be titled similarly in order to accept the payment. If you are working with any federal government payer, please call SOCU to verify the funds can be deposited to the account before you provide an account number. SOCU can work with you to structure your accounts properly to receive your federal government deposits. If you are currently receiving payments into an account that is not titled correctly, SOCU will be contacting you. Direct deposits authorized to go to an account that does not bear the name of the rightful payee will be returned without notice.

Don't Tax my Credit Union!

Congress is considering possible legislation to reform the U.S. tax code. If this happens, all tax exemptions, including the credit union tax status, could be gone. We must ensure our voice is heard on Capitol Hill, and that there is no doubt in Congress that a tax on credit unions is a tax on 96 million Americans, and therefore unthinkable. NEWS CORNER

Each year, all financial institutions are REQUIRED to remit "unclaimed property" to the State of Illinois (or member's last known state of residency). SOCU accounts that have not had activity for 5 years or more by June 30, 2013 ("dormant account") will be charged a \$25 dormant account fee. In October 2013, if no transactions have been done to activate the account, the balance of these dormant accounts will be remitted to the State Treasurer for safekeeping. If you have any accounts that you have not used for some time, please make a deposit or withdrawal to your account by October 1st to ensure your account is not closed and remitted to the State Treasurer. Any account remitted to the State of Illinois can be claimed from the State of Illinois by any account owner or a claim can be made by an heir. Visit icash.illinois.gov to search by name. You or your family may have cash or property waiting to be claimed!
